IRISH SHOW ASSOCIATION LTD GENERAL RULES 2022

For the efficient running of the championships all concerned are requested to read and observe the Rules set out below.

A. Qualifying rounds (qualifiers)

Oualifying rounds will take place at eligible shows selected by the Irish Show Association.

B. Responsibility of shows holding qualifying rounds

- 1. Selected shows must hold a separate class for each qualifier from which the highest placed animals will qualify.
- 2. The qualifier class, if possible, should be held as the first class in the relevant section of the
- 3. Shows must ensure that the qualifiers are held strictly in accordance with the relevant rules
- 4. No other sponsor may be involved in Oualifiers "No Prize money to be paid to qualifiers"
- 5. Shows may charge an entrance fee for each qualifying class. The ISA will award a rosette to the successful qualifiers on appearance at the final
- 6. Shows hosting a Championship Final may not hold a qualifier for that Championship on the day of the Final other than by agreement with the ISA. However, shows who hold qualifiers for Horses, Ponies, Cattle may ask exhibitors to enter the exhibit in at least one other class at their show on the day.
- 7. Animals qualified for Finals are not eligible to enter in any other class at the show where the Final is held other than a qualifying Class for another Competition,
- 8. Shows should appoint competent Person to act as Stewards, who must ensure that animals (or other exhibits) which are eligible to compete & those whose documentation is in order are allowed to proceed to the judging ring.
- 9. Animal Passports & Micro Chips where applicable **should** be read by a Veterinary Surgeon appointed by the show.
- 10. On completion of judging, Stewards should instruct the successful competitors to attend at the Show Secretary's Office within one hour & to complete the necessary documentation for entry to the championship final.
- 11. The Show should appoint a well briefed officer, who will be in attendance at the Secretary's office, & who will assist exhibitors to complete the necessary documentation for participation in the final & to collect the relevant entrance fee.

12. Show Secretaries must forward completed result cards, together with appropriate fees to the ISA within three days following the holding of the show. (N.B. Shows must return results cards marked "(No Competition)" for any or all of the events for which no animal or exhibit has been selected.

D. responsibility of Exhibitors

- A. Exhibitors accept that the Judge's decision is final in all cases. Any abuse of Judges will not be tolerated. Where a dispute or cause for complaint arises, the matter should only be dealt with under the section F. below.
- Winners of qualifiers are themselves responsible for entering their animal (or exhibits) for the final in accordance 10 & 11. above, within one hour of qualifying.
- C. Winners of qualifiers will compete in the final
- **D.** The ISA in conjunction with the sponsor reserve the right to alter or amend the rules of any competition as may be necessary or appropriate.
- **E.** Shows and competitors must contact the Irish Shows National Office for details of any championships and not the sponsor involved
- **F.** Objections must be lodged in writing with the ISA representative at the show or the Show Secretary within half an hour of the completion of judging. Together with a fee of €50 or other stated fee, which is refundable in the event of the objection being upheld.
- **q.** Any Exhibitor who makes a false declaration or misrepresents a fact regarding themselves or their exhibit is liable to disqualification and or forfeiture of any prize awarded.

E. responsibility of shows

hosting Championship Finals

- A. A Deduction of 5% of the prize money is to be collected by the Show and forwarded to the ISA within 30 days of final.
- B. Championships finals should start not later than 2pm on the day of the show and the advertised time of starting should be adhered to as far as practicable, if necessary, other shows classes should be either postponed or relocated to allow for this.



RULES & REGULATIONS

- 1. Open & Confined: Confined events refer to the Kenmare rural area & Clonkeen. The open events refer to confined area plus all other areas.
- **2.** Any handler whose animal is not in his/her control may be asked to remove said animal from the arena/show grounds, at the discretion of the judge or Stewards.
- **3.** Prize Winners: i.e. -1^{st} , 2^{nd} 3^{rd} , in all classes.
- **4.** All exhibits must be owned by the person exhibiting at the Show, otherwise they will be disqualified.
- **5.** Persons making entries and failing to send exhibits shall forfeit all entry fees paid.
- **6.** The Horticultural, Home Craft and Children's section entries must be handed into the Marquee with entry fees on the evening prior to the Show **from 4:00 8:00pm.**
- **7.** All other entries, other than the afore-mentioned will be accepted at the show-ground on the day or prior to entering the show ring.
- **8.** All vehicles in Show grounds are parked at owners' risk, no responsibility is accepted for loss or damage to property.
- 9. Admission at Gate: Adults €10.
- **10.** The Committee will take the utmost care of all exhibits. However, it will not accept responsibility for any accident, loss or damage to livestock or property.
- **11.** Judge's decision will be final in all categories.
- **12.** Fireworks, Pellet guns, Bangers, Spray paint, Balloons, Bubbles, Stink Bomb are not to be sold at Trade Stands. Trade Stands found to be selling these products will be removed from the show ground.
- **13.** The winners of cups in 2022 must give an under-taking in writing to the Committee that the cups will be handed up to the Secretary before 1st June 2023 in as good condition as they were received.
- **14.** No exhibits may be removed until 4pm on Show Day or without the permission from the Chairperson.
- **15.** Objections in any class must be lodged in writing with the Secretary before 5:00pm on the day of the Show by a fee of €50. The fee to be returned if the objection is upheld. Objections will be considered at the first meeting of the Show Committee whose decision shall be final.
- **16.** The Committee reserves the right to reject or return any entry without assigning a reason, to cancel the class or competition, or to postpone the Show, to remove any animal or exhibit at any time during the Show and shall not be liable for compensation or otherwise arising out of the holding or abandonment or alteration of the date of Show.
- **17.** The Show Committee reserves the right to replace or substitute any prize money, by cup, trophy or nomination, or vice versa.
- 18. Perpetual Trophies & Cups can never be won outright.
- **19.** Kilgarvan Show is run under the rules of the Irish Show Association.
- **20.** All Animals to be led.
- **21.** The society shall not be responsible for any mistakes in the entry forms or catalogue
- **22.** Prize money will be posted to exhibitors four weeks after the show.
- **23.** All cheques, money orders & postal orders to be made out to Kilgarvan Show.
- **24.** One attendant will be admitted free with each exhibit.
- **25.** Ground may be uneven, please exercise caution.
- 26. If you are selling food at the show, you will be required to be Health Service Executive Registered
- **27.** Insurance Indemnity must be on insurance company headed paper or have insurance company stamp impressed thereon.
- 28. Stand owners/agents must clean up their area before leaving the showgrounds

Specific Requirements – Sheep

Identification

All sheep must be identified individually with appropriate ear tags issued in accordance with the requirements of the National Sheep Identification System (NSIS)

Movement Documentation

All consignments of sheep being moved must be accompanied by a completed dispatch document. Individual details of each sheep in the consignment must be recorded on the document. Sheep from non-restricted flocks only can be moved to shows. In the case of flocks restricted following diagnosis of scrapie, sheep possessing the ARR/ARR genotype only may be exhibited. The movement of these ARR/ARR genotype sheep must be accompanied by the relevant movement permit (SCR/10), which can be obtained from the local District Veterinary Office in the county where the flock is located.

AIM Notification

The movement of sheep to and from an Agricultural Show within the State must be recorded on AIM. This is done using a copy of the owner sheep dispatch document as follows.

- **1.** The owner/keeper presents the signed and completed dispatch document to the show secretary who checks it to ensure that it is completed in full.
- 2. The show secretary fills in the MART section of the dispatch document with
 - **(A)** The show numbers.
 - **(B)** The date of the move back to the source holding
 - **(C)** Stamp it with the show stamp
 - **(D)** Sign the dispatch document
- **3.** The show secretary then forwards the completed pink section of the dispatch document to the local DVO within seven days of the show movement.
- **4.** The show secretary keeps white copy for his/her records
- **5.** The source/destination keeper keeps the bottom yellow copy to enter it into their flock register.

Ultimate responsibility for fulfilling this requirement lies with the Show Secretary.

Flock register

All movements of sheep to and from shows must be recorded in the keeper's flock register.

Exports to Northern Ireland

All sheep must be accompanied by a TRACES intra-community trade certificate for ovine animals. A TRACES message, corresponding with the TRACES certificate, will be sent for each animal or consignment being dispatched to the show (this will be performed by Department Officials of the DVO). Exhibitors are advised to contact the show society in Northern Ireland well in advance of any show to determine the suitability of the show for return of animals (e.g. premises and sheep status) and whether the authorities will have officials and veterinary staff present to supervise and process documentation for animals returning to origin.



Discipline

The Irish Show Association expects and will insist upon appropriate behaviour from all Exhibitors and other participants in any of the activities at our Member Shows and will not tolerate inappropriate behaviour.

Disciplinary Procedures:

Complaints of misconduct against an Exhibitor or other participant at a Member Show shall be investigated and adjudicated upon by a subcommittee appointed by the Irish Show Association. The said subcommittee shall consist of three members of the board of the Irish Show Association and shall be known as the Disciplinary Committee. The Disciplinary Committee shall seek to ensure the existence of consistent effective, fair and transparent complaint procedures and shall act in accordance with natural and constitutional justice.

Procedure:

A complaint of misconduct/inappropriate behaviour against an Exhibitor or other participant in a Member Show Shall be made in writing and delivered to the Secretary of the relevant Member Show within 72 hours.

A copy of the complaint shall be sent by the Secretary of the Member Show to the National Secretary of the ISA. A copy of the complaint will be sent by the National Secretary to the person or persons against whom the complaint is made. A person or persons against whom a written complaint is made shall have a period of 14 working days from date of receipt of the claim to reply to the said complaint; such reply shall be made in writing

Both parties shall state whether an oral hearing of the complaint is sought. The Disciplinary Committee shall be entitled to hold an oral hearing in regard to the complaint whether or not sought The Disciplinary Committee shall decide in each case whether to hold such an oral hearing in respect of the complaint, or any part thereof and there shall be no appeal from such decision of the Disciplinary Committee

The Disciplinary Committee shall, at any time, seek further information from either party. In the event of either party refusing or failing to provide such further information within the time specified by the Disciplinary Committee, the Committee shall be entitled to make a decision on the complaint and/or to hold an oral hearing of the complaint in the absence of a copy of such further information being received by the Disciplinary Committee from either party.

Sanctions:

In the event of a first incident of inappropriate/unacceptable behaviour being deemed to be proved against the offender, the Disciplinary Committee shall issue a written warning to the offender. In the event of any subsequent incident, the Disciplinary Committee shall be entitled to impose sanctions on the offender, including a prohibition on such offender participating in any of the events/activities at any Member Show of the ISA, provided always that in the event of a first incident of inappropriate/unacceptable behaviour being deemed by the Disciplinary Committee to constitute gross misbehaviour, the Disciplinary Committee shall be entitled to impose such sanctions on the offender as it deems appropriate, including the prohibition on such offender from participating in any of the events/activities of any Member Show of the ISA

The decision of the Disciplinary Committee shall be final:
